STANDING RULES OF Assistance League® of Ventura County

1. Membership

1.01 Voting Member

- (a) All voting members shall:
 - (1) Attend meetings, as required;
 - (2) Participate in and support the philanthropic programs and fundraising activities of the chapter;
 - (3) Have the right to vote and hold office;
 - (4) Pay annual chapter dues;
 - (a) New members joining December 1 through April 30 shall pay ½ Chapter dues to include membership through April 30. Regular dues will be due that May 1.
 - (5) Assume a member's share of financial obligations voted by membership.
 - (6) Serve two (2) shifts per month; one (1) shift shall be served at the Bargain Box and the other shift at the choice of the member. A shift is defined as the scheduled time necessary to staff a philanthropic program or Bargain Box. A Voting member may request an adjustment to shift requirements by submitting a written request to the Membership Committee for review. Shift requirements may be adjusted upon the recommendations of the Membership Committee with the approval of the Board;
 - (7) Serve on a chapter committee.
 - **(b) Voting Life Member**: A voting life member shall be exempt from paying national and chapter dues.

Limited Service Member: To be eligible to apply for limited service, a voting shall have been a voting member of the chapter for at least eight (8) years or president; and shall submit a written request to the Membership Chairman, for approval, no later than February to be effective at the beginning of the next

total of five members per year may be granted limited service. Members on limited shall serve one (1) shift per month at Bargain Box or a philanthropic program.

1.02 Nonvoting Member

- (a) All nonvoting members shall:
 - (1) Support the mission of the chapter;

- (2) Pay annual chapter dues; and
- (3) Assume a share of financial obligations as voted by membership.
- **(b)** Sustaining Member: A sustaining member shall have completed eight (8) years as a voting member of the chapter; and
 - (1) May serve on chapter committees;
 - (2) May attend chapter regular meetings;
 - (3) Shall not vote or hold office.
- (c) Associate Member: An Associate member:
 - (1) May participate in philanthropic programs and fundraising activities of the chapter;
 - (2) May serve on chapter committees;
 - (3) May attend chapter regular meetings;
 - (4) Shall not vote or hold office.
- **(d) Professional Member:** A professional member shall be employed twenty (20) hours or more per week or be a student with twelve (12) or more units; and
 - (1) Shall volunteer one shift per month at the Bargain Box or a philanthropic program;
 - (2) May serve on chapter committees;
 - (3) May attend regular chapter meetings;
 - (4) Shall not vote or hold office.
- (e) Las Patronas Auxiliary Member: A Las Patronas auxiliary member:
 - (1) May participate in philanthropic programs and fundraising activities of the chapter;
 - (2) May serve on chapter committees;
 - (3) Shall pay chapter and auxiliary dues.
- (e1) Las Patronas Auxiliary Associate Member: A Las Patronas associate member:
 - (1) Shall support the fundraising activities of the auxiliary;
 - (2) Shall pay chapter and auxiliary dues.
- **(f) Nancy R. Brandt Auxiliary:** A Nancy R. Brandt auxiliary member:
 - (1) May participate in philanthropic programs and fundraising activities of the chapter;
 - (2) May serve on chapter committees;
 - (3) Shall pay chapter and auxiliary dues.

- (f1) Nancy R. Brandt Auxiliary Sustaining: A Nancy R. Brandt auxiliary sustaining member shall have completed a minimum of eight (8) years as a voting member of the auxiliary; and
 - May participate in and support philanthropic programs and fundraising activities of the auxiliary;
 - (2) May attend regular auxiliary meetings;
 - (3) Shall pay chapter and auxiliary dues.
- (f2) Nancy R. Brandt Auxiliary Associate: A Nancy R. Brandt auxiliary associate member:
 - (1) May participate in and support philanthropic programs and fundraising activities of the auxiliary;
 - (2) Shall pay chapter and auxiliary dues.
- (g) Assisteens[®]: An Assisteens auxiliary member:
 - (1) May participate in and support philanthropic programs and fundraising activities of the auxiliary;
 - (2) Shall attend auxiliary meetings and have the right to vote and hold office;
 - (3) Shall pay auxiliary dues;
 - (4) Shall serve a total of twenty (20) service hours.
- **1.03** Leave of Absence. No special chapter obligations.
- 1.04 Procedure for Change of Classification and Resignation.
 - (a) Requests for change in membership shall be submitted to the Membership Chairman.
- 1.05 Member Information Form and New Member Orientation.
- (a) Member Information. Member Information Forms shall be completed by all members and maintained as required by Assistance League. Relevant contact information, emergency information, and other required personal data shall be recorded on the Member Information Form.
- **(b) Orientation**. Members shall receive orientation, which shall include national organization, chapter and auxiliary information.
- (c) Right to Vote. Upon payment of dues, a new voting member shall have the right to vote.
- (d) New Member Orientation. The New Member Orientation Chairman shall coordinate new member orientation and training. New member orientation and training requirements shall include Assistance League School, Girls' Club/Teen Club, Operation School Bell[®], and the Bargain Box.

1.06 Responsibilities of Membership and Service Requirements

- (a) Policies. Members shall sign policies as required by chapter, which shall be maintained as required by Assistance League.
- **Service Hours.** Members shall report service hours as required.
- (c) A voting member shall serve two (2) shifts per month: one (1) shift shall be served at the Bargain Box and one (1) shift at the philanthropic program of the member's choice, (Assistance League School, Girls Club/Teen Club, Operation School Beel). If desired both required shifts may be served at the Bargain Box in lieu of the additional philanthropic program shift. A shift is defined as the scheduled time necessary to staff a philanthropic program or Bargain Box.
- (d) A member scheduled to volunteer at a philanthropic program or Bargain box is responsible for obtaining a replacement. A member shall be required to volunteer for two (2) shifts if the member fails to serve or obtain a replacement.

2. Board

- **2.01 Attendance.** Members of the Board shall attend Board meetings, Board development and Board training.
- **2.02 Absence**. Members of the Board shall notify the President of any planned absence prior to the Board meeting and arrange for a report to be submitted.
- **2.03 Elected Members.** Only elected members of the Board, with the exception of the Parliamentarian, shall attend Board meetings. Non-board members may be invited to present a report at an appointed time, but shall not be present during deliberations.
- **2.04 Resignation.** Resignation from the **B**oard shall be dated and signed, delivered to the President and effective upon receipt.

3. Committees

- **3.01 Attendance.** Each committee member shall attend committee meetings; shall notify chairman prior to committee meeting of any planned absence.
- **3.02 Procedure Books.** Committee chairmen shall maintain procedure books and present to a successor at end of term.
- **3.03 Job Descriptions.** Annually, committee chairmen shall review and update job descriptions for Board approval.
- **3.04 Minutes.** Each committee shall have recorded minutes.
- **3.05** Each committee shall meet at beginning of fiscal year to organize and at end of fiscal year to evaluate activities; conducting interim meetings as needed.

4. Philanthropic Programs

- **4.01 Identification.** Philanthropic programs shall be identified with the Assistance League name.
- **4.02 Approval.** Each philanthropic program, new, amended or terminated, shall be approved by the membership by a 2/3 vote.
- **4.03 Evaluation.** The membership shall evaluate each philanthropic program at a minimum of every two (2) years.

- **4.04** Name and Description. Philanthropic programs are:
 - (a) Operation School Bell: New clothes, shoes and supplies provided to schoolchildren.
 - **(b) Assistance League School**: School for developmentally delayed children.
 - (c) Girls Club/Teen Club: After school and summer program for girls.
 - (d) B.U.F.F.Y. Bear: Provides cuddly bears for children in traumatic situations.
 - **Teens Helping Teens:** Provides clothing, supplies and food cards to foster and homeless teens.
 - (f) Assault Survivor Kits: Provides clothing for assault victims.

5. Resource Development/Fundraising

- **5.01 Identification.** Each fundraising activity or event shall be identified with the Assistance League name.
- **5.02 Approval.** Each fundraising activity or event, new, amended or terminated, shall be approved by the membership by a 2/3 vote.
- **5.03 Evaluation.** The membership shall evaluate each fundraising activity or event at least every two (2) years.
- 5.04 Name and Description. Fundraisers are:
 - (a) Bargain Box, thrift shop
 - (b) Authors Luncheon
 - (c) Boutique and Luncheon
 - (d) Annual Appeal
 - (e) Debutante Ball
 - **(f)** Come Travel with Us

6. Finance

- **6.01 Designation of Assets.** Annually, the Board shall designate unrestricted net assets sufficient for one (1) year's total operating expenses. (**National Policies for Chapters** Finance)
- **6.02 Leadership Training Registration.** Registration fees for Leadership Training attendees shall be paid by chapter.
- **6.03** Proposed Expenditure. Any proposed expenditure over \$1,000 requires three (3) estimates.

7. Chapter Facility

No special requirements

8. General

- **8.01 Mailing Lists/Rosters.** No outside groups or individuals shall be allowed access to chapter mailing lists nor shall members use membership rosters for outside business activities.
- **8.02** Members transferring from another chapter shall serve a period of chapter orientation to be determined by the Membership Committee. One-half (1/2) of former chapter Voting years, not to exceed four (4), shall be granted toward Sustaining classification.
- **8.03** Philanthropic Program Chairmen may volunteer their two (2) shifts per month requirement at their program.
- **8.04** The Treasure, President and Assisteens® Coordinator are exempt from shift requirements.
- **8.05** A voting member on temporary Leave of Absence shall have shift requirements waived for the length of the leave granted.
- **8.06** Each member is required to provide merchandise for the Bargain Box.
- **8.07** Business unrelated to Assistance League may not be announced at Board or regular meetings.
- 8.08 Appointed Chairman shall hold office for a term of one (1) year or until their successor is nominated. No chairman shall be eligible to serve more than three (3) consecutive terms in the same office unless a special waiver is granted by the Board.

9. Adoption and Amendment of Standing Rules

- **9.01** Adoption and Amendment. These standing rules may be amended or new standing rules adopted at any regular meeting by two-thirds (2/3) vote without previous notice, or by majority vote if the members are provided with notice at the previous regular meeting or thirty (30) days written notice.
- **9.02 Suspension.** A standing rule may be suspended by majority vote, during a meeting, for that meeting only, and will be in full force and effect at the close of the meeting.
